

AND WHEREAS THE MANAGING TRUSTEES named above are willing to accept the office of the trustees for the purpose of carrying out the wishes of the SETTLER of the trust under the provision and direction set forth herein, so as to enable to pursue at vowed object.


## THIS INDENTURE WITNESSETH AS FOLLOWS

- 1- NAME: the name of the trust shall be MOHAMMAD ALI JAUHAR MOHAMMAD ISLAAM MEMORIAL TURST.
- 2- PLACE: The principal of the office of the trust shall be situated at BILARI Post & Tehseel Bilari Distt. Moradabad up or such other place as the managing trustees may from time to time decide. The trust may also carry on its work at any other place, as decided by the managing Trustees.


### 5- FUNDS

The managing trustees may accept donation grant subscription, aids or contributions from any person, Governments, local authorities or any other charitable institutions, in cash or in kind including immovable property without any condition or terms inconsistent with the object of the trusts. While applying such receipts to the objects, with specific direction to treat the same as part of the corpus of the trust or separate fund shall be funded accordingly.

### 6- INVESTMENTS

- i. The power of recution of fund will remain in the hand of the Chairman of the trust.
- ii. That the managing trustees shall manage the trust fund, carry on any business with the trust fund /or enter into partnership on behalf of the trust, as they may deem fit.
- iii. That the managing trustees shall manage the trust fund and investments thereof as a prudent man would do the same. They shall recover all outstanding and meet all recurring and other expenses incurred in the upkeep or managements thereof.
- iv. IT IS DECLARED that the managing trustees shall each year apply the residue of the income of the trustees Estate or any parts of the trusts Estate in or towards all or any time and from time to time apply also trust Estate or any parts of the public charitable propose aforesaid and without prejudice to generality of their power subject to the limitation or conditions contained above, in or towards any one or more of the following and in such proportion

- v. That the managing trustees shall receive and hold the income of the trust on behalf and for the benefit of the beneficiaries under the trust.
- vi. IT IS HEREBY FURTHER AGREED AND DECARED that the surplus and unapplied portion of the said income, if any, arising in any one or more year shall be accumulated by investing the same and the resulting income thereof from time to time in any of the investments in which the trust funds are directed or authorized to be invested and shall be credited to an account to be called "surplus Accounts" and the managing trustees shall have power in any subsequent year to years to expend and employ the same is the same extent as if such accumulations or parts thereof had been part of the income of the year in which the same area or is sought to be expended and employed as aforesaid subject to the provision of the income-tax laws or any other laws that may be in force from time to time.

#### 7- BOARD OF TRUSTEES

- i. The affairs of the trust shall be wholly and exclusively be governed by a board of the trustees, which shall consist of not less than two and not more than twenty member.
- ii. Mohammad Faheem s/o Mohammad Irfan the managing trustees shall act as president of the trust and preside at all meetings of the trust.
- iii. The board of trustees may nominate any other person to the board of trustees, if it deems fit.



8- Managing trustees and their duties

### A) Chairman:-

- i. To grant permission to discuss other topic which are other than regular programs of the trust
- ii. To look after the overall working of the trust.
- iii. Alone with secretary add, delete or amended the clause of the trust deed.
- iv. To give final decision on the complaints and problems received from the members.
- v. The chairman of the trust will have the power to appoint the secretary and the treasurer of the trust on his will.

#### B) SECRETARY:-

- i. The secretary shall try his best and retain the goodwill of the trust as well help in obtaining donation and donors of the trust.
- ii. Call and decide on the programs of the meeting by the approval of the president.
- iii. Write the minutes of the meeting.
- iv. Look after and control the work of the trust.
- v. Call urgent meeting with prior permission of the president.



## 9- POWER AND DUTIESOF MANAGING TRUSTEES

The managing trustees shall be entitled to utilize and disperse either the net income of the trust estate and/ or parts of the corpus thereof for maintain and/or conducting establishments for the charitable purposes and trust hereinabove set also as they in their institutions and/or establishments having one or more of the charitable objects hereinabove set out.

- a) The Managing Trustees shall have power to appoint managing committee for each institution runs under the trust.
- b) The managing trustees shall have power and shall be entitled to collect. Recover and receive dividends rents, profit, interest and other income of the TRUST ESTATE and to pay there out all taxes, rates, assessments, expenses and outgoing for a collection in respect thereof and for the managements of the TRUST ESTATE and for administering and carrying out the trust hereof.
- c) The managing trustees shall be entitled from time to time to accept from any person or persons deriding to make gifts or donation upon the TRUSTS and subject to the terms, provision power and conduction therein such money or properties as the donors desire from time to time give on the aforesaid trust and on the terms and condition herein contained.

- f) The managing trustees for the time being of these presents shall be respectively charitable only for such moneys and securities as they shall respectively actually receive notwithstanding their respectively singing any receipt for the sake of conformity and shall respectively be answerable and responsible only for their own respective acts receipts omissions neglects and defaults and not for those of each other for that bankers broker, auctioneer or other person with whom or into

- g) The managing for the time of being for these presents shall have full power to compromise or compound all actions suits other proceedings and all differences and demands and to refer any such differences or demand to arbitration and to adjust, settle and approve all accounts relating to the trust estate and execute release and to do all other things relating thereof without being answerable or accountable for any loss occasioned thereby.
- h) If and so often as any of the managing trustees hereunder appointed or any future managing trustees or trustees presents shall die or shall leave India for more than one year or shall desire to rattier from or refuse to act or become incapable to act in the trust of these presents or otherwise, it shall be lawful for the surviving or counting managing trustees for the time being of these presents or for the proving executors or administrators of the last surviving managing trustees to appoint a new trusts within one month who will be only the successor or legal heir of the previous managing trustees. The person appointed in palace of such previous Managing trustee will also be called managing trustees.
- i) For the purpose mentioned above or any of them, the managing trustees shall be at liberty to enter into sign execute and deliver all such contacts, deed, assurances and entitled to incur all legitimate expense which they consider to be beneficial to and in the interest of the trust.
- j) The managing trustees shall be entitled to invest the trust Estate or such other funds mentioned under the head "INVESTMENTS" in this deed as per the laws of the nation or any parts thereof on the mortgage of any immovable property situated in any part of the republic of India and the managing trustees shall also be entitled to purchase immovable properties, including vacant land of any tenure and to construct building and other structure thereon as the managing trustees may consider necessary and in the interest of the trust and they shall also be entitled to pull down and demolish and to –rebelled any building or erection as they may consider necessary and the interest of the trust, AND the managing trustees shall have power to alter, very to transfer the investments from time to time in such manner as the managing trustees may think fit and proper and in the interest of the trust.
- k) The managing trustees shall be entitled to obtain tenancies and/or take any promises and/or properties as they may consider proper and in the interest of the trust.

### 10- WORKS OF TRUSTEES -

Trustees or trustee will work as per the gaudiness given by the managing trustees time to time. Trustee will give his suggestion and full supports to the managing trustee in the interest of the trust.

### 12- ACCOUNTS AND AUDIT -


- A. The managing trustee shall keep proper books of accounts of all the assets, liabilities and income and expenditure Accounts and balance sheet for every year as on last day of March.
