5- FUNDS

The managing trustees may accept donation grant subscription, aids or contributions from any person, Governments, local authorities or any other charitable institutions, in cash or in kind including immovable property without any condition or terms inconsistent with the object of the trusts. While applying such receipts to the objects, with specific direction to treat the same as part of the corpus of the trust or separate fund shall be funded accordingly.

6- INVESTMENTS

- i. The power of recution of fund will remain in the hand of the Chairman of the trust.
- ii. That the managing trustees shall manage the trust fund, carry on any business with the trust fund /or enter into partnership on behalf of the trust, as they may deem fit.
- iii. That the managing trustees shall manage the trust fund and investments thereof as a prudent man would do the same. They shall recover all outstanding and meet all recurring and other expenses incurred in the upkeep or managements thereof.
- iv. **IT IS DECLARED** that the managing trustees shall each year apply the residue of the income of the trustees Estate or any parts of the trusts Estate in or towards all or any time and from time to time apply also trust Estate or any parts of the public charitable propose aforesaid and without prejudice to generality of their power subject to the limitation or conditions contained above, in or towards any one or more of the following and in such proportion





- vi. **IT IS HEREBY FURTHER AGREED AND DECARED** that the surplus and unapplied portion of the said income, if any, arising in any one or more year shall be accumulated by investing the same and the resulting income thereof from time to time in any of the investments in which the trust funds are directed or authorized to be invested and shall be credited to an account to be called “**surplus Accounts**” and the managing trustees shall have power in any subsequent year to years to expend and employ the same is the same extent as if such accumulations or parts thereof had been part of the income of the year in which the same area or is sought to be expended and employed as aforesaid subject to the provision of the income-tax laws or any other laws that may be in force from time to time.


7- BOARD OF TRUSTEES

9- POWER AND DUTIES OF MANAGING TRUSTEES

The managing trustees shall be entitled to utilize and disperse either the net income of the trust estate and/ or parts of the corpus thereof for maintain and/or conducting establishments for the charitable purposes and trust hereinabove set also as they in their institutions and/or establishments having one or more of the charitable objects hereinabove set out.

- The Managing Trustees shall have power to appoint managing committee for each institution runs under the trust.
- The managing trustees shall have power and shall be entitled to collect. Recover and receive dividends rents, profit, interest and other income of the **TRUST ESTATE** and to pay there out all taxes, rates, assessments, expenses and outgoing for a collection in respect thereof and for the managements of the **TRUST ESTATE** and for administering and carrying out the trust hereof.
- The managing trustees shall be entitled from time to time to accept from any person or persons deriding to make gifts or donation upon the **TRUSTS** and subject to the terms, provision power and conduction therein such money or properties as the donors desire from time to time give on the aforesaid trust and on the terms and condition herein contained.

- d) It shall be lawful for the managing trustees at any time and from time to time to borrow moneys as well as to sell, mortgage, assign, transfer demise or let or less for and any period for however long or otherwise dispose of the deal with the **TRUST ESTATE** including any immovable properties comprised therein or any parts thereof either by public action or by private contract for sale, mortgage, transfer assignments, lease or other disposition without being answerable for any loss occasioned thereby and with power also to execute all necessary assignments, conveyance, mortgage, transfer, leases, sub-lease and other deeds and assurance for assurances for the some and give to receipt and discharge for the mortgage, transfer, or other disposition shall be deemed to be parts of the said estate and shall be deal accordingly.
- e) The receipt of the managing trustees for the purchase money of any property hereby directed or authorized to be sold or for any other money, stocks, funds, shares, securities or investments paid delivered or transferred to them or him by virtue of these presents or in the execution of the trusts or powers hereof shall effectually discharge the person or person having delivered or transferring the same there from and/or from being bound to see to the application or being for the loss or misapplication thereof.
- f) The managing trustees for the time being of these presents shall be respectively charitable only for such moneys and securities as they shall respectively actually receive notwithstanding their respectively signing any receipt for the sake of conformity and shall respectively be answerable and responsible only for their own respective acts receipts omissions neglects and defaults and not for those of each other for that bankers broker, auctioneer or other person with whom or into




whose hands any trust money or securities shall be deposited or come nor the insufficiency in title or deficiency in value or any other loss unless the same shall happen through their own willful default respectively **AND ALSO** the managing trustees for the time being may reimburse themselves or himself or pay and discharge out of the trust estate all expense incurred in or about the execution of the Trusts or power to these presents.

- g) The managing for the time of being for these presents shall have full power to compromise or compound all actions suits other proceedings and all differences and demands and to refer any such differences or demand to arbitration and to adjust, settle and approve all accounts relating to the trust estate and execute release and to do all other things relating thereof without being answerable or accountable for any loss occasioned thereby.
- h) If and so often as any of the managing trustees hereunder appointed or any future managing trustees or trustees presents shall die or shall leave India for more than one year or shall desire to retire from or refuse to act or become incapable to act in the trust of these presents or otherwise, it shall be lawful for the surviving or counting managing trustees for the time being of these presents or for the proving executors or administrators of the last surviving managing trustees to appoint a new trusts within one month who will be only the successor or legal heir of the previous managing trustees. The person appointed in place of such previous Managing trustee will also be called managing trustees.
- i) For the purpose mentioned above or any of them, the managing trustees shall be at liberty to enter into sign execute and deliver all such contracts, deed, assurances and entitled to incur all legitimate expense which they consider to be beneficial to and in the interest of the trust.
- j) The managing trustees shall be entitled to invest the trust Estate or such other funds mentioned under the head **"INVESTMENTS"** in this deed as per the laws of the nation or any parts thereof on the mortgage of any immovable property situated in any part of the republic of India and the managing trustees shall also be entitled to purchase – immovable properties, including vacant land of any tenure and to construct building and other structure thereon as the managing trustees may consider necessary and in the interest of the trust and they shall also be entitled to pull down and demolish and to –rebuild any building or erection as they may consider – necessary and the interest of the trust, **AND** the managing trustees shall have power to alter, vary to transfer the investments from time to time in such manner as the managing trustees may think fit and proper and in the interest of the trust.
- k) The managing trustees shall be entitled to obtain tenancies and/or take any promises and/or properties as they may consider proper and in the interest of the trust.


10- WORKS OF TRUSTEES -


